WILDFIRE WARNING

Our Community Ranger Service have been working tirelessly carrying out extended patrols around Loch Ken during the extreme wildfire warnings and have had to extinguish multiple campfires. Our Rangers are working hard to advise and educate visitors and locals on the risks of fires during the warnings, liaising with landowners, Community Police and Scottish Fire and Rescue Service.

On some occasions, this advice has been met with hostility, with some members of the public not understanding the risks associated with lighting a fire during the extreme dry weather and not complying with the guidance. One camp fire on the shores of Loch Ken was so large and out of control ,Scottish Fire and Rescue Service had to be called in to extinguish.

As a Ranger Service we educate through our schools ranger-led programme and each year we hold an annual cookout event to educate on responsible access and how to protect the environment.

We would urge everyone to act responsibly and not light ANY fires during restricted periods.



Carlingwark Project

As part of our Restoring and Enhancing Carlingwark Loch project, it has been great to work with students from SRUC Barony Campus and Galloway Fisheries Trust. The Wildlife and Conservation Management students have carried out some surveys at Carlingwark Loch to try and establish a base line for the local community to decide on how they might want to manage the loch habitat moving forward.

Galloway Fisheries Trust have been collecting water samples at various times and locations and all the data will be collected and analysed.






